- A Statement of Position (300-500 words) that provides a perspective on the Guiding Principles
- A Letter of Achievement (300-500 words) that describes any achievement on the Character Qualities
- A minimum of 2 Letters of Recommendation.

Finalists will be contacted for an interview.

Criteria for Awards

Awards will be based on meeting the eligibility requirements, the quality and strength of the Statement of Position, significance of the Letter of Achievement, quality of the Letters of Recommendation, evidence to the commitment of the stated Guiding Principles, and the interview.

Annual Awards

Awards will be made on an annual basis, in the Spring of each year. The funds are administered by a 501(c)3 Education, with an annual report posted on our website.

Our Mission

The Future of Freedom Foundation was established in May, 2019, as a 501c(3) education foundation to advance the Founding Fathers' guiding principles of liberty and freedom to future generations.

Our Guiding Principles

- Support of free market economics, capitalism, and American exceptionalism.
- A belief in a limited government, of the people, by the people, and for the people
- A belief in opportunity for all, individual responsibility and opposition of collectivism
- An understanding and appreciation of an *IN GOD WE TRUST* attitude and a belief that the people, not the government are the best stewards of our country's Godgiven resources.
- A belief that the Constitution, as our founding document, was written as a covenant and not as a flexible document, and that the Amendments are intended to protect our freedoms (speech, property, religion, arms).

Our Plan

To provide awards, grants, and scholarships to:
a) students and young adults of exceptional character who demonstrate an understanding, appreciation and support of the guiding principles.
b) organizations and educational institutions

b) organizations and educational institutions whose goals and/or programs are to advance these guiding principles.

"The Future Freedom Foundation is a non-traditional scholarship program that provides support to students who are not necessarily 4.0 GPA and Harvard bound. Eligibility is based on character qualities and an appreciation of our guiding principles. Applicants are NOT required to be going to college. They may be starting a business, going into the military, attending a trade school, or some other journey."

Annual grants, scholarships, or awards will be made on an annual basis. Applicants must be a current High School Senior, have exceptional character, graduate on time, and be preregistered or registered to vote.

Exceptional Character Qualities include an appreciation and love of country, faith, family, and freedom. It also includes a commitment of service to community, hard work, perseverance, and overcoming difficulties and adversity.
